  - <sup>1</sup>Transportation Cost Recovery Rate relates to transportation tolls for the Portland Xpress expansion on Union Gas, TransCanada Pipelines and Portland Natural Gas Transmission System. Approved on June 1, 2018 by the NSUARB.
  - <sup>2</sup>The biannual GCRR for Rate Class 1 <500 GJ/Yr is a 6 month forecast of the monthly adjusted GCRR. This rate will be set on August 1<sup>st</sup> and February 1<sup>st</sup> of each year. Subject to interim adjustment.
  - <sup>3</sup>Cost of Carbon is collected as part of the Nova Scotia government's cap-and-trade system.
- Equivalent pricing includes Municipal Tax Rate Rider A: 5% & Rate Rider B: 1.2% both applicable on Delivery charges only (Effective January 1, 2019).
- Total Variable figures do not include the Fixed Monthly Customer Charges. The Grand Total Variable figures are the Total Variable figures and the Municipal Tax.
